## **Gafta Mediation**

In certain circumstances, parties may wish to refer their dispute to Mediation under Gafta 128. This can be done at any time; for example, before arbitration proceedings have commenced or, indeed, once the parties have embarked on it. With arbitration, the parties have agreed, in their contract, to resolve their dispute in a formal way in accordance with the relevant Gafta Rules. The parties are, therefore, tied into the process and are legally bound by the decision of the arbitrators. Mediation, however, is fundamentally different. Unlike an arbitrator, a mediator's role is not to rule on the dispute. Rather, their role is to try and encourage the parties to reach an agreement on terms that they are both comfortable with. If the parties cannot reach an agreement, then their dispute will simply go back to arbitration. If, however, they do reach an agreement, then the mediator will assist in drawing up a settlement agreement, which, once signed, is contractually binding on both parties.

Things said in a mediation are strictly confidential and any offers made to settle are without prejudice, meaning that they cannot later be referred to in an arbitration if the mediation subsequently breaks down.

In a typical mediation, the mediator will meet with both parties at a neutral venue on the day of the mediation (having first asked them both to send a brief 'position paper' in advance of the mediation hearing). The mediation process will then be explained (including the parties' obligation to keep the matter confidential), brief comments will be sought from the parties as to their respective positions and what they hope to achieve on the day, following which the parties will, usually, adjourn to their own rooms. The mediator's role is to then 'shuttle' between the two rooms, understanding the parties' relevant cases (and weaknesses), with a view to assisting the parties to hopefully arrive at common ground to resolve their differences. Unlike an arbitration, where the legal remedies sought are fixed (most commonly, damages), mediation can often involve more creative solutions, not necessarily limited to the matter in dispute. For example, an agreement to trade on certain specified terms, in respect of any new orders or, indeed, an agreement to place a new order.

Gafta mediation costs just £950 for one day, which includes all the necessary prehearing work, such as reading-in time. Gafta mediation is provided by Gafta's General Counsel, Jonathan Waters, who is a Civil Mediation Council Registered Mediator.

## GAFTA ARBITRATION STATISTICS FOR 2023/2024 FINANCIAL YEAR

The following arbitration statistics are taken from the period 1 October 2023 to 30 September 2024, and any comparisons made are against the same period from the previous financial year.

#### FIRST TIER STATISTICS

Between 1 October 2023 and 30 September 2024 Gafta's arbitration department received a total of 301 new arbitration claims, which is an 11% decrease from last year. Gafta issued 158 first tier awards, a 44% increase. 42 of these claims were settled and withdrawn before issuance of an award. 154 first tier awards proceeded under the 125 Rules of Arbitration, 4 under 126 Rules.

The three most common Gafta contracts used were Gafta 48, 49 and 100 and the most common commodities in dispute were corn (mainly of Ukrainian origin), Wheat (mainly of Ukrainian origin) and Milling Wheat (mainly of Ukrainian origin). Awards issued with damages in US dollars, had an aggregate total of USD 147,584,083.82 awards issued with damages in Euros, had an aggregate total of EUR 73,463,185.66. The awards issued damages in GBP with an aggregate total of £31,638.00. 29 Awards were issued with no damages. The aggregate sum of all damages awarded when converted into US dollars totalled US\$221,078,907.48

#### APPEAL STATISTICS

Of the 158 first tier awards issued, 25% were appealed during the period 1 October 2023-30 September 2024. Gafta issued a total of 52 appeals which is an 18% increase from last year. 60% of the appeal awards upheld the first-tier decision.


#### S.57 STATISTICS

Gafta received 13 applications under section 57 applications of the Arbitration Act 1996. 5 related to appeals and 8 to first tier awards. 10 awards were amended, 1 was dismissed and 1 was both amended and dismissed.

#### **DEFAULTER STATISTICS**

34 companies were posted under Rule 24.1, of which 2 later settled. 3 companies were posted under Rule 24.2, of which 0 later settled, and 0 companies were posted under Rule 10.1 (126 Rules).


