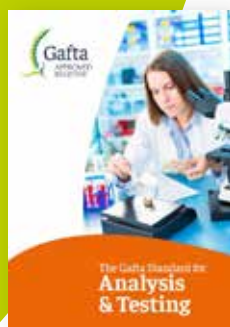

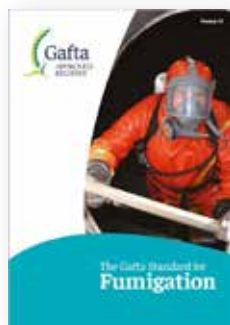


Approved Register of Analysts

Gafta requirement for those providing certificates of analysis for traded agricultural commodities and feedingstuffs.

You must:

- Participate in the Gafta Ring Test Scheme
- Hold a valid Certificate of Conformance to the Gafta Standard for Analysis and Testing **OR** Accreditation to ISO17025



Approved Register of Fumigators

Gafta requirement for those performing fumigation activities at loading and/or discharge of consignments of traded agricultural commodities and feedingstuffs.

You must:

- Hold a valid Certificate of Conformance to the Gafta Standard for Fumigation



Approved Register of Superintendents

Gafta requirement for those professionals who supervise the loading and discharge of traded agricultural commodities, including sampling, measurements, and quality and condition assessments.

You must:

- Hold a valid Certificate of Conformance to the Gafta Standard for Supervision, Sampling and Check Weighing **OR** Accreditation to ISO17020 (Type A)

The Gafta Approved Registers

Gafta runs three Approved Registers for those members who provide their services in support of the trade of agricultural commodities and animal feedingstuffs.



ANALYST

The Gafta Approved Register of Analysts is for those laboratories who provide certificates of analysis for traded goods.



FUMIGATOR

The Gafta Approved Register of Fumigators is for those businesses who provide fumigation services at loading and discharge of consignments of traded goods.



SUPERINTENDENT

The Gafta Approved Register of Superintendents is for those businesses who supervise loading and discharge operations including sampling, measurements, and quality and condition assessments.

It is a requirement of all standard Gafta contract forms that these services are performed by Gafta Approved members.

Using Gafta Approved members ensures:

- Your suppliers conform with the high international standards set by Gafta
- Your suppliers have been audited by an independent third party
- Your suppliers are following the current best practice which is regularly reviewed by industry and stakeholders
- Your suppliers meet your customers' needs and your contractual requirements by adhering to the Gafta Methods and Rules, which provide consistent and up to date processes for their activities
